2. Nomination papers must be delivered to the Returning Officer, The Council House, South Street, Atherstone, Warwickshire, CV9 1DE on any day after the date of this notice between 9.30am - 12 noon and 2.00pm until 4.00pm but no later than 4 pm on Wednesday 3<sup>rd</sup> April 2019.
3. If any election is contested the poll will take place on Thursday 2<sup>nd</sup> May 2019.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Friday 12<sup>th</sup> April 2019. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at The Council House, South Street, Atherstone, Warwickshire, CV9 1DE by 5.00pm on Monday 15<sup>th</sup> April 2019.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at The Council House, South Street, Atherstone, Warwickshire, CV9 1DE by 5 pm on Wednesday 24<sup>th</sup> April 2019.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at The Council House, South Street, Atherstone, Warwickshire, CV9 1DE by 5 pm on Thursday 2<sup>nd</sup> May 2019. The physical incapacity must have occurred after 5 pm on Wednesday 24<sup>th</sup> April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5.00pm on Wednesday 24<sup>th</sup> April 2019
