Interments

Sale of Graves and Ash Plots

(Exclusive Rights of Burial and Erection of Memorial)

9 x 4 grave plot for 3 burials

2 x 2 Ash Plot for 4 cremated remains

Interment Charges (includes administration charges)

(All new graves are dug to triple depth)

First interment in triple grave (at any depth)

Second interment in triple grave (at any depth)

Third interment in triple grave

Interment of Ashes

Scattering of ashes

Walled graves and vaults

Administration fee, 2nd. and 3rd. Interments.

(No new walled graves and vaults are being approved)

From 1 month to 16 years old

New grave plot in adult burial site (triple depth)

Adult interment charges apply for burial in adult burial site

Grave plot in baby section for up to 7 years old exclusive burial for infants (including stillborn)

Cost of plot in baby section

Interment charge in baby section

Cost of designated Ash plot in baby section

Please note maximum height of ash plot headstone is 2ft 6ins.

Memorial Bench - 10 yr exclusive lease of space

Memorial Plaque (Ashes Scattering Wall - one off fee - one plaque per scattering)

Other charges

Topping up of Exclusive Rights of Burial, 10 year blocks, pro-rata to current fee (see above)

Search fee (Family History)

Transfer of deed of exclusive right of burial, including assent of executor, per deed.

Compilation of statutory declaration, per deed.

Renunciation of rights of burial, per deed.

Appointment of new/joint owner, per deed.

In Parish charges apply to:

New burial/ash plots when

The purchaser lives within the parish of Atherstone at the time of purchase

or the grave is being purchased for the interment of a resident of Atherstone (within the parish) regardless of the purchasers address

Interments/Scatterings and Memorials when

The deceased was a resident of the parish of Atherstone at the time of their death

or the deceased was a resident of the parish of Atherstone, until moving into a care setting

For re registrations and other charges when

The new owners live within the parish

For all other circumstances out of parish charges will be applicable
